# Academic Unit Assessment Updates

In AY19-20, academic assessment submissions for all degree programs at main and branch campuses increased 7.4% overall. Undergraduate academic assessment submissions also increased at UNM main and branch campuses.

- Undergraduate Submissions (Main Campus): 75.2%; an increase of 7.9% from last year
- Undergraduate Submissions (Branch Campuses\*): 71.1%; an increase of 22.2% from last year
- Total Undergraduate Submissions: 74.1%; an increase of 12.6% from last year
- Graduate submissions: 61.9%; an increase of 2.6% from last year
- \* not including Los Alamos branch

The Office of Assessment & APR have gained good insights from this year's academic assessment reports. Here are some assessment topics that we have discovered and should lead to fruitful discussions with your instructors/faculty, leadership, and assessment committees to start off the academic year:

- Assessment planning/reporting was challenging due to low faculty engagement. What are ways your college/school/branch can engage and motivate faculty to complete assessment as well as address potential hurdles? What messages are you sending about meaningful and useful assessment? In what ways are you keeping the assessment conversation going?
- Academic units identified particular weaknesses in their assessment practices (e.g., assessment measures, results use, and/or student learning outcomes). What is one area you can strengthen in your programming regarding assessment? How can you make this actionable? Did you know the Office of Assessment & APR will provide support, including one-on-one consultations, customized workshops, and helping facilitate faculty discussions?
- Programs indicated that they are reaching their benchmarks and are maturing in their

# **State of APR - Main Themes**

In AY20-21, seven Academic Program Reviews were conducted, with programs representing the College of Fine Arts, the School of Architecture & Planning, and the College of Arts & Sciences. Due to coronavirus pandemic constraints, all seven were hosted online through Zoom. From self-studies and review team reports, four main themes emerged:

- Academic curricula at UNM are strong and wellpositioned to teach students effectively, while also fulfilling needs across department/programs and NMHED general education mandates.
- Low faculty and staffing levels are a concern and cause issues with facility space, advising, teaching loads, among others, and are inherently unsustainable.
- Academic facilities were at times lacking and were often at a tipping point due to space management concerns. Some teams also noted issues of systemic safety concerns.
- **Diverse faculty represent their student bodies** well. Teams noted that units are also proactively constructing curricula that increases the focus on critical contemporary issues.

assessment processes. Once plateaued, and the same assessment results are experienced year after year, new student learning outcomes or new benchmarks should be set. Discussing the trends and patterns from assessment data is critical for continuous improvement over time, not only for student populations and instruction, but also for the assessment process to continue to be purposeful.

# **Critical Thinking Assessment**



Thank you for participating in UNM's inaugural year of assessing the general education essential skill of

Critical Thinking. With 841 student assignments submitted, we have a robust set of data that we are currently analyzing. Your college/school/ branch individualized reports will be distributed by September 1st, 2021! Please ask your leadership or assessment contact for these results or contact us at assess@unm.edu.

#### Here is what we know so far:

- UNM rated 2.15 in critical thinking (using a 3- point scale) when assignments aligned with the UNM critical thinking rubric. Overall, students are performing at a "developing" level.
- UNM rated **1.99** in critical thinking **when** assignments were not aligned with the UNM critical thinking rubric. This means students are performing at a "highly emerging" level.
- **Assignment alignment** with awhile evaluating a general education essential skill (such as critical thinking), plays an important role in assessing student performance. It is **imperative** for instructors to review the general education essential skill rubrics to align assignments before administering them. When assignments are aligned, ratings focus on student skill building and proficiency rather than on the representation of critical thinking in the assignment design. As noted above, ratings improve when assignments are aligned to the critical skill being evaluated.

# Attention Administrative/Co-curricular **Units!**

Beginning in 2020, we began an **outreach** program to engage co-curricular programs in the assessment process and encourage the development of assessment plans. This outreach included workshops, one-on-one consultations, topic-specific round tables, ongoing support, and the development of a range of planning aids including a co-curricular assessment template.
